

The Syntax Approach

The Texas Capital Texas Equity Index measures the performance of the subset of companies in the Syntax US 3000 Index that are domiciled in the state of Texas. The index is weighted by float-adjusted market capitalization with industry weights set proportional to the state of Texas's industry GDP at each rebalance.

Upside (downside) capture is the ratio of index return to benchmark return during months of positive (negative) benchmark performance.
